

Smalls Acts That Give Back – Pay Your Heating Bill Campaign

- 1. Eligibility:** This Campaign is open only to those who submit an entry form and who are 18 years of age or older as of the date of entry. The Campaign is only open to members of Jeanne D'Arc Credit Union and is void where prohibited by law. Employees of Jeanne D'Arc Credit Union and immediate family members and/or those living in the same household as Employees are not eligible to participate in the Campaign. - 3. Campaign Period:** Entries will be accepted via email, mail or in branch beginning at 8:00AM on Monday, March 8, 2021 EST to 12:00 PM on Friday April 2, 2021 EST.
- 4. How to Enter:** The Campaign must be entered by submitting an entry using the online form. These forms can be found on JDCU.com/smallsacts, in branch, or available through mail upon request. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Jeanne D'Arc Credit Union. YOU may enter only once. YOU must provide the information requested.
- 5. Prizes:** The Winner(s) of the Campaign (the "Winner") will receive up to \$400 toward one heating bill incurred between March 1, 2021 and March 31, 2021. Eligible heating costs include an electric, gas, oil, and propane bill. Submitted bill must be for one billing period only. If more than one billing period is included on bill, Jeanne D'Arc Credit Union reserves the right to choose which bill amount to pay. Payment will be made from Jeanne D'Arc Credit Union directly to the billing company. No cash or other prize substitution shall be permitted. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for Jeanne D'Arc Credit Union to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. Winner(s) will be required to submit a valid heating bill within 7 days of notification as Winner.

- 7. Winner Selection and Notification:** Winner(s) will be selected by an internal judging panel at Jeanne D'Arc Credit Union. One Winner will be chosen on each of the following dates: Friday, March 12, 2021, Friday, March 19, 2021, Friday, March 26, 2021 and Friday, April 2, 2021 by 2:00 PM EST and will be notified by phone or email within five (5) days following selection of Winner. Jeanne D'Arc Credit Union shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 10 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations. Terms & Conditions:** Jeanne D'Arc Credit Union reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond Jeanne D'Arc Credit Union's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, Jeanne D'Arc Credit Union may select the Winner from all eligible entries received prior to the action taken by Jeanne D'Arc Credit Union. Jeanne D'Arc Credit Union reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions.
