Smalls Acts That Give Back - Non-Profit Campaign

- 4. **How to Enter**: The Campaign must be entered by submitting a nomination using the official entry form. These forms can be found on JDCU.com/smallacts, or available through mail upon request. The entry must fulfill all Campaign requirements, as specified, to be eligible to win the prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Jeanne D'Arc Credit Union. Forms must be completed in entirety to qualify.

If Winner cannot be contacted, is ineligible, fails to claim the prize within 2 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. In such case, Jeanne D'Arc Credit Union may select the Winner from all eligible entries received prior to the action taken by Jeanne D'Arc Credit Union.
