

OFFICIAL CONTEST RULES: Tackling Financial Wellness – Financial Friday Challenge

- 1. Eligibility:** This Campaign is open only to those who submit an entry form and who are 18 years of age or older as of the date of entry. The Campaign is only open to members of Jeanne D'Arc Credit Union and is void where prohibited by law. Employees of Jeanne D'Arc Credit Union and immediate family members and/or those living in the same household as Employees are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
- 2. Agreement to Rules:** By participating, the Contestant ("YOU") agree to be fully unconditionally bound by these Rules, and YOU represent and warrant that YOU meet the eligibility requirements. In addition, YOU agree to accept the decisions of Jeanne D'Arc Credit Union as final and binding as it relates to the content of this Campaign.
- 3. Campaign Period:** Entries will be accepted via online or by mail beginning at 8:00 AM on Friday, September 4, 2026 EDT to 11:59PM on Sunday, February 14, 2027 EST.
- 4. How to Enter:** The Campaign must be entered by completing a contest entry form on JDCU.com/tackle. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Jeanne D'Arc Credit Union. There is a limit of 1 entry per participant per week. YOU must provide the information requested.
- 5. Prizes:** Six (6) Winners will be chosen over the course of the campaign; one (1) per month from September 2026 to February 2026. The Winner(s) of the Campaign (the "Winner") will receive an autographed football from New England Cornerback Marcus Jones. No cash or other prize substitution shall be permitted. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. - 6. Odds:** The odds of winning depend on the number of eligible entries received.
- 7. Winner Selection and Notification:** Winner(s) will be selected at random by an internal judging panel at Jeanne D'Arc Credit Union. Six (6) winners will be chosen; one (1) winner chosen each month during the campaign period. Monthly winners will be notified by these respective dates: Wednesday, October 7, 2026 at 2:00 PM EDT; Friday, November 6, 2026 at 2:00PM EST; Wednesday December 9, 2026 at 2:00PM EST; Friday, January 8, 2027 at 2:00PM EST; Friday, February 5, 2027 at 2:00PM EST; and Friday, March 5, 2027 at 2:00PM EST. Winners will be notified by phone or email within five (5) days following selection of Winner. Jeanne D'Arc Credit Union shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 10 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Campaign is conditioned upon compliance with any and all federal, state, and local laws and regulations. Terms & Conditions:** Jeanne D'Arc Credit Union reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Campaign should virus, bug, non-authorized human intervention, fraud, or other cause beyond Jeanne D'Arc Credit Union's control corrupt or affect the administration, security, fairness, or proper conduct of the Campaign. In such case, Jeanne D'Arc Credit Union may select the Winner from all eligible entries received prior to the action taken by Jeanne D'Arc Credit Union. Jeanne D'Arc Credit Union reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Campaign or website or violates these Terms & Conditions.
